To Process your application we will need you to complete this form in full and provide your signature in all designated places. All persons over 18 wishing to reside at the premises will be required to complete & sign a separate application form & provide all relevant documentation.

Accompanying this application we will require 100 points of current identification per person & proof of aboriginality- we will not accept or process an application with less than 100 points.

You will be contacted whether or not you are successful. We endeavor to have applications processed within 48 hours, though this may take a little longer over weekends & depending on contactility of references. On approval of successful application.

All documentation collected for successful applications will remain on file. Unsuccessful applications will be held for one month -for collection or for you to apply for another property & will then be shredded to maintain your privacy.

Final application approval is at landlords discretion - no reason shall be given for unsuccessful applications.

Once approved you cannot move into a property until you have paid bond (equal to 4 weeks rent) & first 2 weeks rent. We will accept Housing Commission Bond Loans but you still need to pay 2 weeks rent in advance.

Eligibility:

- 1. Must be a Current Financial Member of Mununjali Housing and Development. (Form 1)
- 2. Must Live in the Beaudesert Shire for the previous 6 months of the application.
- 3. Must be of Aboriginal/Torres Strait Islander decent / or accepted by the Aboriginal Community of Beaudesert. (Form 8)
- 4. Must have completed the official Mununiali Housing Application Form.(Form 5)
- 5. Must have submitted official application to the Mununiali Office BEFORE the closing Date
